WE CLOSED THE 2017-2018 FISCAL YEAR WITH \$10.09 MILLION IN OUTSTANDING LOANS TO MEMBERS OF THE NORTHERN CALIFORNIA JEWISH COMMUNITY -- THE LARGEST AMOUNT IN OUR HISTORY. THIS INCLUDES \$412,377 OUTSTANDING IN A STAND-ALONE, NONSECTARIAN LOAN PROGRAM, WHICH IS SEPARATELY FUNDED.

WE DISBURSED 393 NEW LOANS LAST FISCAL YEAR, BRINGING THE TOTAL NUMBER OF LOANS IN CIRCULATION TO 1,067. MOST NOTABLY, AS TUITION EXPENSES CONTINUED TO INCREASE, 233 STUDENTS RECEIVED EDUCATION LOANS TOTALING \$1.9 MILLION; 39 INDIVIDUALS ESCAPED THE CRUSHING WEIGHT OF HIGH-INTEREST DEBT WITH DEBT CONSOLIDATION LOANS TOTALING \$514,857, AND 16 ENTREPRENEURS WERE ABLE TO ACHIEVE THEIR DREAM OF LAUNCHING A BUSINESS, RECEIVING BUSINESS LOANS TOTALING \$632,232.

WE ARE PROUD OF OUR 121-YEAR TRADITION OF PROMOTING SELF SUFFICIENCY AND FINANCIAL RESPONSIBILITY THROUGH INTEREST-FREE AND COST-FREE LENDING. WELL OVER 100,000 INDIVIDUALS AND FAMILIES HAVE BEEN ABLE TO ACHIEVE THEIR DREAM OR OVERCOME A CHALLENGING FINANCIAL SITUATION BECAUSE OF OUR WORK. IN THE LAST 29 YEARS ALONE, WE HAVE DISBURSED APPROXIMATELY \$75 MILLION IN LOANS; AS LOANS ARE REPAYED, THE FUNDS ARE RECYCLED INTO NEW LOANS, ALLOWING US TO UTILIZE OUR ASSETS TO ASSIST OTHERS IN NEED.

AFTER HURRICANE HARVEY FLOODED HOUSTON IN AUGUST 2017, AND THE NAPA, SONOMA, AND MENDOCINO FIRES DESTROYED 7,000 STRUCTURES AND KILLED 44 PEOPLE IN OCTOBER 2017, WE CREATED A DISASTER RELIEF FUND THAT RAISED \$60K TO ASSIST FIRE AND FLOOD VICTIMS. USING THOSE FUNDS, AND MORE FROM OUR RESERVES, WE LOANED \$47,530 TO OUR SISTER AGENCY, THE HEBREW FREE LOAN ASSOCIATION OF HOUSTON, TO HELP THEIR COMMUNITY RECOVER, AND WE DISBURSED \$52,500 IN LOANS TO ASSIST JEWISH RESIDENTS OF NORTHERN CALIFORNIA REBUILD THEIR HOMES AND LIVES.

MISSION, PROGRAM, AND SERVICE: PROVIDING INTEREST-FREE LOANS TO HELP MEMBERS OF OUR COMMUNITY BECOME FINANCIALLY SELF-SUFFICIENT. IN THE 2018 FISCAL YEAR, WE GAVE OUT \$4,201,000 IN NEW LOANS AND INCURRED OPERATING EXPENSES OF \$1,321,400. THESE OPERATING EXPENSES EQUALED 31% OF THE TOTAL NEW LOAN EXPENSE.

BECAUSE OF THE UNIQUE NATURE OF HEBREW FREE LOAN'S SERVICES, WE FIND THAT THE PRESENTATION OF FUNCTIONAL EXPENSES REQUIRED BY GAAP ACCOUNTING STANDARDS DOES NOT ACCURATELY REPRESENT THE REALITY OF OUR FINANCIAL MODEL. RATHER THAN ANALYZING OUR SEPARATE FUNCTIONAL EXPENSE AREAS AS A PERCENTAGE OF OPERATING EXPENSES, WE PRESENT HERE AN ANALYSIS OF OUR EXPENSES AS A PERCENTAGE OF THE LOANS WE MAKE EACH YEAR THROUGHOUT OUR COMMUNITY. THIS PRESENTATION PROVIDES A FULLER PICTURE OF THE RELATIVE COSTS TO OUR ORGANIZATION OF (A) MAKING THESE LOANS AND (B) RAISING FUNDS FOR NEW LOANS, AS FOLLOWS:

- OUR PROGRAM EXPENSES IN FY 2018 WERE \$633,600, OR 15% OF TOTAL NEW LOAN EXPENSE.

- OUR FUNDRAISING EXPENSES IN FY 2018 WERE \$512,100, OR 12% OF TOTAL NEW LOAN EXPENSE.

- OUR ADMINISTRATIVE EXPENSES IN FY 2018 WERE \$167,100, OR 4% OF TOTAL NEW LOAN EXPENSE.

WE PRIDE OURSELVES ON KEEPING OUR EXPENSES LOW SO THAT WE HAVE MORE MONEY AVAILABLE FOR THE COMMUNITY, AS THIS PRESENTATION DEMONSTRATES.
