WE DISBURSED 591 INTEREST-FREE LOANS DURING THE YEAR, TOTALING \$8.6  
MILLION. THIS IS SIMILAR TO THE AMOUNT DISBURSED LAST YEAR, BUT 52 MORE  
LOANS, WHICH MEANS WE HELPED MORE PEOPLE. WE CLOSED THE YEAR WITH 1,670  
LOANS OUT IN THE COMMUNITY (125 MORE THAN LAST YEAR) TOTALING \$20.5  
MILLION.

OUR 18 LOAN PROGRAMS HELP PEOPLE PURSUE LIFE GOALS AND ADDRESS  
FINANCIAL HARDSHIPS. STUDENT LOANS WERE THE MOST FREQUENTLY REQUESTED  
LOAN TYPE, FOLLOWED BY DEBT CONSOLIDATION AND GENERAL NEEDS. THE NEED FOR  
ASSISTANCE CONTINUES TO INCREASE, AS MANY STILL STRUGGLE TO FIND THEIR  
FOOTING AFTER LOSING INCOME OR DEPLETING SAVINGS DURING THE PANDEMIC.  
WE ARE WORKING HARD TO GROW OUR RESOURCES TO MEET COMMUNITY NEED.

HELPING SMALL BUSINESS OWNERS LAUNCH OR EXPAND THEIR BUSINESSES IS A  
CORE FOCUS OF OUR LENDING. THIS YEAR, WE MADE 36 BUSINESS LOANS  
TOTALING \$1.3 MILLION (80% MORE LOANS AND 115% MORE IN DOLLARS THAN  
LAST YEAR). AMOUNTS RANGED FROM \$10K TO \$50K.

MANY APPLICANTS DON'T YET HAVE A BUSINESS TRACK RECORD, SO CAN'T  
QUALIFY FOR BANK LOANS. FOR EARLY-STAGE ENTREPRENEURS BOOT-STRAPPING  
THEIR BUSINESSES, OUR LOANS BEING INTEREST-FREE IS A GAME CHANGER.  
WE'VE SUPPORTED FOOD AND BEVERAGE COMPANIES, MEDICAL PRACTICES, LAW  
FIRMS, RETAIL STORES, COACHING AND CONSULTING PRACTICES, DEVELOPERS OF  
PRODUCTS (E.G., SMART TOOTHBRUSHES, PICKLEBALL GRIPS, AND VIDEO GAMES),  
AND OTHER TYPES OF ENTERPRISES.
